- Support the definition of key EU secondary legislation, incl. the Network Code for Demand-side Flexibility and the Implementing Act on data access for Demand-side Flexibility
- Monitor legislative developments regarding the digitalisation of the energy system and contribute to shape policy recommendations and advocacy efforts

- A university degree (Master's or equivalent) in energy, digitalisation, economics or related field
- Good understanding of the EU energy system and its digitalisation, notably the role of active consumers/prosumers and the evolution of System Operators as neutral market facilitators
- Professional experience with System Operators and good understanding of the European Network Codes and Guidelines
- Analytical, curious, pragmatic and flexible attitude
- Fluency in written and spoken English required, other European languages are an asset
- Strong organisational and communication skills
